### MINUTES OF THE SPECIAL MEETING

### JUNE 1, 2012

A quorum was declared by the Chairman and the meeting was called to order.

Mr. Don Templeton advised the Corporation members that the notice of the meeting had been posted at the entrance of the office of the Educational Enhancement Funding Corporation on May 25, 2012. A copy of that notice is attached hereto and is an integral part of the minutes (see Attachment #1).

The Chairman asked for consideration of the minutes for the January 27, 2012 meeting. Mr. Roby moved to approve the minutes as presented, seconded by Mr. Karels. All members present voted aye. Motion carried.

### MASTER SETTLEMENT AGREEMENT PAYMENT UPDATE

Mr. Templeton reported the April 2012 Master Settlement Agreement payment was \$27,134,906 or only 84% of the original 2002 projection. This is due to declined tobacco sales and the major three tobacco companies withholding payments and sending them into disputed payment accounts. The June 1, 2012 turbo redemption payment was \$11,818,000. The Reserve Fund was invested with Scaldis Capital which was rated A-1+ by Standard and Poor's, P-1 by Moody's and F1 by Fitch.

The Educational Enhancement Funding Corporation bonds are rated as follows: Series 2002A are rated A1 by Moody's and BBB by Standard and Poor's. The Series 2002B are rated A3 by Moody's and BBB by Standard and Poor's.

### **SERIES 2002 POTENTIAL REFUNDING**

Mr. Templeton explained that Jack Arnold of Dougherty & Company LLC and Barclays Capital are looking into a potential refunding of the Series 2002A & B bonds and Mr. Templeton explained that he will update the Board should the refunding be determined to be advantageous and as these discussions move along.

### MEIERHENRY-SARGENT L.L.P CONTRACT

Mr. Todd Meierhenry explained the Meierhenry-Sargent FY-2013 Contract on file with the Educational Enhancement Funding Corporation. D.J. Mertens moved to approve the contract, seconded by James Roby. Dennis Haan, Doug Hajek, Ken Karels D.J. Mertens, James Roby, James Spies and Tom Graham voted aye. Motion carried.

# SOUTH DAKOTA HEALTH AND EDUCATIONAL FACILITIES AUTHORITY FY-2013 CONTRACT

Mr. Templeton explained the South Dakota Health and Educational Facilities Authority FY-2013 Contract on file with the Educational Enhancement Funding Corporation. Dennis Haan moved to approve the contract, seconded by Ken Karels. Dennis Haan, Doug Hajek, Ken Karels D.J. Mertens, James Roby, James Spies and Tom Graham voted aye. Motion carried.

### EDUCATIONAL ENHANCEMENT FUNDING CORPORATION FY-2013 BUDGET

Mr. Templeton reviewed the Educational Enhancement Funding Corporation FY-2013 Budget (*see Attachment #2*) in detail. Ken Karels moved to approve the budget, seconded by James Spies.
